 PROCLAMATION: Mayor Palmer called the meeting to order welcomed all, invocation by John Walsingham, Pledge of Allegiance by all. Mayor Palmer also recognized Martha Compton who is a candidate for Washington County School Superintendent, Mrs. Compton stated that she was a lifelong resident of Washington and a 33-year educator and asked for consideration in the upcoming election.

- IV. NON-AGENDA AUDIENCE: Effective October 1, 2013, Florida Statute 286.0114 mandates that "members of the public shall be given a reasonable opportunity to be heard on a proposition before a Board or Commission." Everyone shall have three (3) minutes to speak on the proposition before the Council.
- V. Clerk:
  - Water Reports: Clerk presented the members with the end of the month collections reports, after discussion motion by Mr. Walsingham, second Ms. Carter to accept the reports into record, motion carried with Hagan, Carter, Walsingham, Rightenburg, and Palmer voting Yes.
  - CDBG: Resolution 2020-002 and Exhibits A, B, & C: Clerk stated that the Resolution, and Exhibits A, B, & C are requirements for the CDBG Grant Program. Clerk read Resolution 2020-001 by title after discussion motion by

Mr. Hagan, second Mrs. Rightenburg to adopt Resolution 2020-001 as read along with attachments A, B, & C, attached and made apart of the minutes, motion carried with Hagan, Carter, Walsingham, Rightenburg, and Palmer voting yes.

- Tower Company Offer: Clerk presented the members with an offer from the Tower Co. on purchasing the perpetual lease on the tower site at the GMR Park after discussion the council with a motion by Mr. Walsingham to authorize the clerk to negotiate with the Tower Co. and to counter offer \$130,000.00 and have the authority to go as low as \$120,000.00 without coming back to the council, second Mr. Hagan, motion carried with Rightenburg, Walsingham, Carter, Hagan, and Palmer voting Yes.
- Fire House Value Engineering Contract: Clerk presented the members with an email (attached) along with an agreement between the Town and D & B Builders, Inc., and Notice of Award (attached). After discussion motion by Mr. Hagan, second Mr. Walsingham to enter into and agreement with D & B Builders, Inc. in the amount of \$896,819.00 on the Town of Wausau-Wausau Fire Station, and to authorize the Mayor to Execute the required documents along with the Notice of Award, motion carried with Hagan, Carter, Walsingham, Rightenburg, and Palmer voting Yes.
- Set Date and Time for Workshop: After discussion motion to set employee workshop on May 28, 2020 at 5:00 PM by Ms. Carter, second Mr. Hagan, motion carried with Rightenburg, Walsingham, Carter, Hagan, and Palmer voting Yes.
- Cancelation of 2020 ball season: After discussion motion by Mr. Walsingham second Mrs. Rightenburg, to cancel the 2020 spring ball season, motion carried with Hagan, Carter, Walsingham, Rightenburg, and Palmer voting yes.
- Fun/Possum Day Update: Clerk presented the members with the minutes of the Wausau Volunteer Fire Department (attached) and an email from Attorney Carter stating that in his opinion the VFD had made the right decision to cancel the 2020 Possum/Funday Festival and parade. After discussion and with Mayor Palmer recognizing Mr. James Walsingham who stated that he was the newly elected Chairman of the Wausau Community Development Club who asked the Council to consider a online/virtual Possum King and Queen contest along with an online Possum Auction and Quilt Auction. Mr. Paul Goulding stated that he had talked with Mr. Walsingham and was willing to do anything the Council authorized to assist in this endeavor after discussion motion by Mr. Hagan, second Mr. Walsingham to concur the VFD not to have the 2020 Fun/Possum Day

Festival and Parade, and to authorize the Wausau Development Club and Mr. Goulding to go forward with the virtual Possum King/Queen and online auction motion carried with Hagan, Carter, Walsingham, Rightenburg, and Palmer Voting yes.

- Mosquito Spraying Quote: Clerk presented the members of the Council with a quote from Lee Duke to do mosquito spraying within the city limits from May-October for the amount of \$1105.20 this would be 1 time a week for 30 weeks, after discussion motion by Ms. Carter, second Mr. Walsingham to enter into contract for mosquito control spraying with Lee Duke, motion carried with Rightenburg, Walsingham, Carter, Hagan, and Palmer voting Yes.
