

NOTICE TO RECEIVE SEALED BIDS
TOWN OF WAUSAU CDBG-DR / 2ND AVENUE DRAINAGE

The Town of Wausau will receive sealed bids from any qualified person, company or corporation interested in providing construction services for the replacement of the storm water drainage culvert system and restoration of the damaged and undermined pavement and road base on 2nd Avenue providing safe access and passage for residents. This project is funded with Community Development Block Grant Disaster Recovery (CDBG-DR) funds through the U.S. Department of Housing and Urban Development and through the Florida Department of Commerce (formerly DEO) and awarded to the Town of Wausau under CDBG-DR agreement **M0109** for recovery from Hurricane Michael and to repair and harden 2nd Avenue and drainage and to mitigate the infrastructure against the impacts of future storms.

Bids will be received until **10:00 AM (CST)** on **June 11, 2025** at the Town of Wausau, 1607 Second Avenue, Wausau, FL 32463 or P.O. Box 39, and will be opened and read aloud on **June 11, 2025 at 10:05 AM (CST)**. The Bid will be awarded on **June 19, 2025 at 5:00 p.m. CST** to the lowest, most responsive and responsible bidder. The Town of Wausau reserves the right to reject any and all bids. All Bids shall remain firm for a period of sixty days after the opening.

All bidders shall comply with all applicable Federal, State and local laws concerning licensing registration and regulation of contractors doing business to the State of Florida. This project is federally funded and must be implemented in compliance with all federal requirements, including but not limited to Davis-Bacon, Anti-Kickback, Contract Work Hours and Safety Standards Act, Section 3, and 2 CFR 200.
